# China: Uncle Sam's Latest Boogeyman

For several years now, drumbeats of anti-China talk have been getting louder and louder. Despite many years of economic cooperation, with many US manufacturers moving factories to China and Chinese goods flooding US

stores, Trump has begun a trade war. Escalating bouts of sanctions are damaging the economies of both countries. Verbal attacks from the US government and the media are increasing in both number and intensity, accusing China of everything from spying on us with the Tik Tok app, to having deliberately sent us COVID.

Now, in the run-up to the coming election, China has become the "mud" each party is slinging at each other. Trump recently said that "Joe Biden's entire career has been a gift to the Chinese Communist Party." In return, Biden accused Trump of "rolling over for the Chinese" during the rise of the

Covid crisis, claiming that he would have demanded that US medical personnel be admitted into China to attack the virus at its point of origin.

All this mutual anti-Chinese ranting has caused hate crimes against all Asians to increase dramatically in the US.



Even more dangerously, US naval forces are going toe-totoe with the Chinese military in the South China Sea. This new "Cold War" with China may accidentally turn hot, with another "Gulf of Tonkin" incident triggering a nuclear World War III.

Why, is all of this happening? The seeds of the answer lie in a doctrine laid out in 2000 by the

neo-conservative "Project for A New American Century." It argued that no foreign country should be allowed to grow strong enough to threaten US dominance. As the only remaining "superpower" after the collapse of the USSR in 1991, the US should use its

> military strength to control the rest of the world. It called for a massive buildup of the military, including "missile defense" systems, investment in high-tech weaponry and new generations of nuclear weapons, and the control of both cyberspace and outer

space. Their proposal coincided with a Dept. of Defense publication earlier that same year calling for the US military to achieve "full spectrum dominance;" the ability to overcome any adversary anywhere on land, sea, air, or space. Politicians agreed with both, which is why US military spending keeps increasing, and (Cont. on p. 6)

# U.S.A. - The "Endless War" Nation

Since declaring Independence in 1776, in all but 11 years, the US has been involved in some form of war or other combat. In the early years that too often meant genocide against Native Americans. And even before completing colonization from "sea to shining sea," the US began assembling an empire.

Today, that involves having around 800 military bases in 80 foreign countries. (At the height of the wars on Iraq and Afghanistan, that number was more than 2,000 bases.)

How much is it costing? the *Costs of War Project* estimates that over these last 19 years, the United States has spent or obligated about \$6.4 trillion. That total is increasing daily.

The US is involved in wars in at least 24 countries. Wars mean people in those places are being "displaced" – turned into refugees. How many? No one is keeping accurate count, but just the 8 most violent ones (Afghanistan, Pakistan, Iraq, Somalia, Yemen, Libya, Syria and the Philippines) likely have resulted in at least 37 million persons being displaced. And that's a very low-side-guess. The total could be from 48 to 59 million persons displaced.

The US doesn't count all persons killed in wars. But in five of the wars (Afghanistan,

Pakistan, Iraq, Libya and Yemen) it's estimated that US combat has killed around 800,000 persons. But there are also lots of indirect deaths; caused by destruction of local infrastructure, healthcare services, hospitals, and food sources. Those deaths could be upwards of 3 million people.

For 11 of the 19 years since 9/11, a Republican has occupied the White House and for 8 of those 19 years, a Democrat has occupied the White House.

# The "Costs of War" Project is Tracking People Displaced by US Wars

"The findings of our report are basically asking — the United States has been fighting wars continuously, as you said, for 19 years. We're looking at what the effects of these wars have been. The Costs of War Project has been doing this for about a decade. We wanted to look specifically at how many people had been displaced by these wars. Basically, we found that no one had bothered to investigate how many people had been displaced by the wars in what are now, actually, at least 24 countries that the United States has been involved in.

We found that, in total, at least 37 million people have been displaced in just eight of the most violent wars that the United States has either launched or participated in since 2001. That's Afghani-

stan, Pakistan, Iraq, Somalia, Yemen, Libya, Syria and the Philippines. And that's a very conservative estimate. We found that the actual total could be up to 48 to 59 million.

I think we have to pause on these numbers - to wrap one's mind around them - 37 million people displaced is difficult, in fact, and I think it requires some active effort. It certainly did for me.

Thirty-seven million, to put it in historical perspective, is more people displaced by any war since at least the beginning of the 20th century, with the exception of World War II. And if our larger less conservative methodology is accurate, the 48 to 59 million estimate, that is comparable to the displacement one saw in World War II.

Another way to try to wrap

one's mind around just the 37 million minimum figure, is that it's about the size of the state of California. Just imagine the entire state of California disappearing, having to flee their homes.

AMY GOODMAN: Can you talk about why those eight countries? And can you

correlate that with U.S. wars abroad?

**DAVID VINE**: We wanted to look specifically at the wars the United States has launched, so the overlapping war in Afghanistan and Pakistan, the War in Iraq, of course; wars that the United States has significantly esca-

lated, Libya and Syria, Libya along with — and Syria, along with European and other allies; and then wars the United States has participated in significantly, in ways including providing battlefield advisers, providing fuel, arms and others, in Yemen, Somalia and the Philippines.


We aren't saying the US is solely to blame for this level of displacement. Clearly, there are other actors, other governments, who also responsible. But the US has played a disproportionate role in waging war, in launching war and in perpetuating war over the last 19 years.

The displacement documented in this paper cannot simply be dismissed or normalized as "unintended consequences" or "collateral damage." The displacement and other suffering must be central to any analysis of the post-9/11 wars and to any conceivable consideration of the future use of military force by the United States or any other country.

The legitimacy and efficacy of war should be questioned more than ever given nearly two decades of disastrous outcomes. One must also ask what steps the US and other responsible parties have taken - and will take - to repair and make amends for the damage inflicted on the many millions of people displaced by the post-9/11 wars.

# Julian Assange Extradition Update

As of Sept. 19th, 2020, Julian Assange's Extradition Hearing has passed the ninth day in London, UK. He has been under some type of confinement for over 10 years for publishing war crimes and human rights abuses.

Many witnesses testified on behalf of the defense. John Sloboda, of the Iraq Body Count organization, revealed that the Iraq War Logs revealed the torture and abuse of prisoners, with 37 million people displaced from the Middle East and 12 million deaths. He said that these helped to end the Iraq war and were done in the public interest.

Carey Shenkman, a civil rights and constitutional lawyer, testified regarding the Espionage Act, Section 793 E. The US prosecutor tried to get him to say that journalists can be prosecuted for possession and dissemination of national defense information. He said, "It's not that simple." There is no precedent for prosecuting a journalist for publishing classified information. They went back and forth citing numerous cases.

The prosecution has been telling every witness before testifying that J. Assange is not being tried for releasing classified documents, but that is not what the Extradition Order states. The prosecution

is saying he is being charged with revealing names of the people in the documents. Daniel Ellsberg and John Goetz reputed this allegation. John Goetz was working with Julian at Der Spiegel when the documents were released. He said Julian was obsessed with keeping the documents secure and preventing harmful disclosures. Daniel Ellsberg said when he released the Pentagon Papers he didn't redact them at all. "No journalist anywhere in the world is safe from life imprisonment, if J. # Daniel Ellsberg Defends Julian Assange

Vietnam era whistle-blower, 89-year-old Daniel Ellsberg said that he feels "a great identification," with both Julian Assange and his source Chelsea Manning, who "were willing to suffer the risk of imprisonment or even death to get information to the American public."

Ellsberg told the court that Assange exposed what were clearly war crimes in Iraq and Afghanistan... He further told the court that during his prosecution in 1971 he was not allowed to tell a jury why he did what he did, and said that in US espionage cases matters of motive are not allowed not to be considered.

"Julian Assange could not get a fair trial in the United States," he concluded.

Ellsberg repeatedly denied that people had been harmed by Wikileaks actions, a main plank of the US extradition case...

Asked about people in Iraq and Afghanistan being forced to leave their homes after being named by WikiLeaks, Ellsberg replied, "None of these threats appears to have been carried out... He said that some people might have left their countries because of this and he regretted that, but added, "How many refugees have been caused in that region by US wars?"

He told the court, "They are pretending to care about the people in this region when their policies have shown their absolute contempt for them over the last 19 years."

## Is Your Neighborhood Cool? Not the Case for Low-Income Ones!

As climate changes, and American cities warm, this means that urban poor residents will experience more heat than the wealthy in many American cities, based simply by virtue of where they live. Such health problems as asthma, COPD, and heart disease spike.

In dozens of major U.S. cities, including Baltimore, low-income neighborhoods are more likely to be hotter than their wealthier counterparts, according to a joint recent investigation by NPR and the University of Maryland. Deadly health consequences can result, based on emergency calls for assistance. Ninety-seven municipalities were studied, and a strong correlation was found in the vast majority. The temperature disparity between neighborhoods in some cities were 10 degrees Fahrenheit.

However, disparities in neighborhoods stretch far beyond climatological ones. The quality of schools and grocery stores are two major concerns, which has locked urban poor neighborhoods, such as Sacramento's Meadowview, into decades

of educational and food insecurity. Many residents live in rental houses and apartments, which means less equity (including generational equity) than families in richer neighborhoods. Such facilities as hospitals, senior centers, banks, and restaurants (nonfast-food) are rare. Manicured parks, with ponds and other recreational facilities, cannot be found. Tree-lined streets (think Midtown and East Sac) are also rare. What is

common: unemployment and inequality.

Recommendations for changing this: Encourage your local politicians to invest, NOW, in hard and soft infrastructure to deliver facilities and services to these neighborhoods which have suffered institutional neglect for way too many decades.

Take Action: Contact your City Council representative and/or the Sacramento Tree Foundation.

## SOA Graduate Convicted for Jesuit massacre in El Salvador

On Friday, September 11, 2020, a Spanish court convicted SOA grad Inocente Montano, a former Army Colonel and Minister of Security in El Salvador, for the November 1989 murders of five Spanish Jesuit priests... at the Jesuit-run University of Central America (UCA) in San Salvador.

After 30 years, this is an important step towards holding the highest levels of the Armed Forces accountable for the November 1989 massacre.

Montano was part of a group of high-level military officers who gave the order to 'eliminate' Jesuit Ignacio Ellacuría, rector of the UCA, for his leadership in working to broker a peace agreement to end the war in El Salvador. No other members of the high command have been prosecuted for ordering and planning the massacre. El Salvador refused to extradite members of the military high command to Spain (Montano was extradited from the U.S.) and there has yet to be a trial of the intellectual authors in El Salvador itself.

Furthermore, the U.S. in general, and the SOA in particular, have never been held accountable for their role in training and

empowering members of the military who ordered the murders at the UCA, as well as numerous members of the Atlacatl Battalion - a counterinsurgency battalion created at the SOA - who carried out the massacre.

In a statement of their own, the the Jesuit's University of Central America said:

"The case in the National Court of Spain clearly shows that the Armed Forces... functioned as a criminal machine for serious attacks against Salvadoran population and the rule of law, making use of power that goes beyond the functions granted to the military by the Constitution.

The resolution of the trial

in Spain will help both the national conscience and the Salvadoran judicial system to take real steps in favor of truth and justice, not only in this case, but also in all those related to serious violations of human rights.

Judicial convictions for homicide or terrorism are never cause for joy. They express the sad reality of a moment in history and the worst of the human condition, its ability to gravely offend life and break with the brotherhood to which we are all called. But they are a formal, legal and democratic recognition of the truth, and an encouragement and a guarantee of non-repetition of these inhuman acts."

unhoused and now a member of the Sac Poor People's Campaign, and Matthew Windsor, resident of Stockton Blvd Encampment and all telling their brave stories.

Other speakers included: Crystal Sanchez, Sacramento Homeless Union, Cathleen Williams, of the Sacramento Homeless Organizing Committee and Faye Wilson Kennedy, of the Sacramento Area Black Caucus and Sac Poor People's Campaign.

Though the City/County homeless system has provided porta-potties and hand-washing stations, and recently virus testing, in recognition of these encampments as shelter-inplace areas for unhoused people, accessible cooling and breathing centers have not been provided.

Now the City, in particular Councilman Eric Guerra, refuse to stop this eviction, which will force hundreds of people to wander through the adjoining neighborhoods, putting themselves and hundreds of residents at risk.

The Stockton Boulevard Business Improvement District should be ashamed of pushing for this illegal eviction during a climate emergency and a pandemic. The homeless and their community advocates, will be pushing back against it!



I joined the Longshoremen, other labor groups, church groups, and a group calling themselves "Sandinistas" to

was to boycott trade military dictatorship

In spite of the success of the event - which included speakers from Chicago labor, Cuauhtemoc Cardenas, who was working to establish a Mexican progressive/leftist party, and the S.F. Mime Troupe doing a new play about the U.S. government's nefarious doings in the Americas - the Pinochet dictatorship lasted for 17 years.

What I learned from the event has lasted a lifetime: If you want change, organize! "Don't mourn; organize!" has been added to my early teachings.
